#### Procedures for Application for Foreign Residents Regarding Their Location of Residence and Residency Status

In accordance with the abolishment of the Alien Registration System on July 9, 2012, the Alien Registration Card has been replaced with Residence ("Zairyu") Card or Special Permanent Resident Certificate. Further, as the Basic Resident Registration Law was revised, foreign residents (i.e., those who meet the requirements for medium- or long-term stay visa, or special permanent resident visa) are now issued a residence record.

When moving out of Ueda City, you also must notify the City Hall beforehand (within 14 days of the move).

# Application and Notification for Residence ("Zairyu") Card, etc. (For Special Permanent Residents: Procedures at the Regional Immigration Bureau)

Application and notification procedures for Residence ("Zairyu") Card are the same as those for holders of Special Permanent Residence Certificate, as a general rule. All of these procedures, as well as those for renewing residence period, changing residence status, etc. must be done at the Regional Immigration Bureau.
